Live-in Caregiver Employer/Employee Contract - Canada ...

If you hire a live-in caregiver, you are required by federal law to register as an employer with the Canada Revenue Agency (CRA). When you register, the CRA will give you an information guide with the necessary forms and instructions. You must give your employee a record of employment (ROE) when the employee's work term with you finishes.

Generally, a senior home care worker who is hired to care for the day to day needs of an aging adult is an employee. As such, the employer, either the family or the agency, is responsible for employment taxes, record keeping and required insurance matters.
