A Declaration of Invalidity, often referred to as an annulment, requires the moving party to show the court that the marriage is invalid under state law. (MCA 40-1-402) No-Fault Dissolution means that a party does not need a reason for filing for a dissolution of marriage. That is, in Montana, a person can ask the court to end their marriage simply because they do not want to be married anymore.
